

RELEASE, WAIVER OF LIABILITY AND INDEMNITY AGREEMENT

This Release, Waiver of Liability and Indemnity Agreement, when signed and returned, will serve as a liability release for the person below for their attendance or participation in the Continental Tire the Americas, LLC The Central Texas Association for Pupil Transportation Bus Rodeo held on or about April 14, 2018 ("EVENT") subject to the terms and conditions herein. By attending or participating in the EVENT, the undersigned, for myself and my personal representatives, assigns, heirs, legal guardians, estate and next-of-kin, hereby executes and delivers this Release, Waiver of Liability and Indemnity Agreement ("AGREEMENT") in favor of Continental Tire the Americas, LLC, and its parent company, affiliates, subsidiaries, successors, assigns, insurers, reinsurers, and lessees, and each of their directors, employees, agents, owners, members, shareholders, trustees, and/or attorneys (collectively, the "COMPANY GROUP"), and understands and agrees as follows:

I acknowledge and agree that my attendance and/or participation in the EVENT, which includes, but is not limited to the observation of or participation in a facility tour, vehicle test driving at certain locations and/or any other associated activity authorized by the COMPANY GROUP, may have **inherent risks, dangers, hazards, and conditions known and unknown, foreseeable and unforeseeable, that could result in personal injury, illness, property damage or death to me ("RISKS")**. I further acknowledge and agree that all or some of such RISKS may be caused by the negligence or carelessness of me, others, one or more of the COMPANY GROUP, accidents, breaches of contract, forces of nature, dangerous or defective equipment or property owned, maintained, or controlled by the COMPANY GROUP and/or other causes or liability without fault (collectively, "CAUSE").

I assume all RISKS and the responsibility for any and all claims, losses, damages, liabilities, expenses and/or costs that may be incurred by me or against any member of the COMPANY GROUP, whether for bodily injury, disability, illness, property damage, wrongful death, loss of services or otherwise related to or arising from my attendance, observation or participation in the EVENT, regardless of the CAUSE (collectively, "LOSSES").

If I become aware of any RISKS, including but not limited to any unsafe condition, I will immediately advise the COMPANY GROUP and take all necessary steps to protect myself from such RISKS. I agree that no representations have been made to me with respect to the existence or non-existence of any RISKS nor will I rely on any such representations if they are made to me.

I agree that my attendance and/or participation in the EVENT shall be subject to and conducted in accordance with all COMPANY GROUP rules, policies, procedures and requirements.

I certify that there are no health-related reasons or problems which would preclude me from attendance or participation in the EVENT. I consent to receive medical treatment which may be deemed advisable in the event that LOSSES occur by emergency medical services paramedics or other medical personnel and I will cooperate with the medical examination, including without limitation any testing, such as alcohol and drug testing, as part of the medical examination.

I RELEASE, WAIVE, DISCHARGE, HOLD HARMLESS, COVENANT NOT TO SUE, DEFEND AND INDEMNIFY THE COMPANY GROUP FROM ALL LOSSES.

I acknowledge and agree that the COMPANY GROUP has not made any effort or taken any action (except for those that may be required under law in the ordinary course of business), and shall not be required to make any effort or take any action, to protect me from any of the RISKS.

My attendance and/or participation in the EVENT may be photographed and/or recorded. I consent to, and license the COMPANY GROUP to use my name, voice and likeness and/or any photographs, videos, film, and/or recordings ("MATERIAL") made of me while on the EVENT for any legitimate purpose by any member of the COMPANY GROUP. I agree that the COMPANY GROUP shall have full ownership of the MATERIAL and the right to use the MATERIAL in perpetuity. I release COMPANY GROUP from any and all liability arising out of their use of the MATERIAL. I agree not to make any claim against COMPANY GROUP as a result of the recording or use of the MATERIAL and waive any claim to compensation relating to or arising out of COMPANY GROUPS use of the MATERIAL.

Information disclosed to me by any member of the COMPANY GROUP, whether orally, in writing, graphically, electronically or otherwise, that is clearly identified orally or in writing by the COMPANY GROUP as confidential information, shall be deemed confidential, proprietary and owned by the disclosing member of the COMPANY GROUP, and may not be used or disclosed by me to any third party without express written permission from the COMPANY GROUP.

This AGREEMENT is governed by the laws of the State of North Carolina and is intended to be as broad and inclusive as is permitted by the laws of the State of North Carolina. If any portion of this AGREEMENT is deemed invalid, the balance will have full legal force and effect.

I agree that each member of the COMPANY GROUP is an intended beneficiary of this AGREEMENT.

Upon the request of the COMPANY GROUP, in its sole discretion, I will immediately leave the EVENT and/or cease my attendance, observation or participation in the EVENT.

I acknowledge and agree that the COMPANY GROUP is relying on this AGREEMENT in permitting me to attend or participate in the EVENT.

I acknowledge that I must have and show proof of a valid, unexpired drivers' license to operate a vehicle during the EVENT. Except with the prior written consent of the COMPANY GROUP, I shall not take any photographs or videos or otherwise make any recordings during my attendance and/or participation in the Event. COMPANY GROUP has the right to prohibit any and all use of the images/video.

I HAVE READ THIS AGREEMENT AND UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT. I have signed this AGREEMENT voluntarily and without additional verbal representations, statements or inducements made by any person apart from those written within this AGREEMENT.
